

Notice of the Sources of Fund Distributions

Section 19(a) of the Investment Company Act of 1940, as amended, requires the payment of any distribution to be accompanied by a written notice that discloses the sources of a payment if it made from any source other than the fund's net income. This notice is intended to satisfy the requirements under Section 19(a).

YieldStreet Prism Fund Inc. (the "Fund"), a closed-end management investment company declared a \$0.20 quarterly distribution to shareholders of record on June 9, 2021 and paid on June 16, 2021. No action is required on your part.

The following table sets forth the estimated amounts and sources of the current distribution. In accordance with generally accepted accounting principles, the Fund estimates the following percentages of the total distribution per share attributed to net investment income and return of capital or other capital source.

Net Investment income	\$0.15904	79.52%
Return of Capital	\$0.04096	20.48%
Total Distribution (per common share)	\$0.20000	100.00%

The amounts and sources of distributions reported in this Section 19(a) notice are only estimates, are likely to change over time, and are not being provided for tax purposes. A final determination of the tax character of the distributions paid by the Fund will not be known until the completion of the Fund's fiscal year. The actual amounts and sources for accounting and tax reporting purposes will depend upon the Fund's investment experience during the remainder of the fiscal year and may be subject to changes based on tax regulations. The final determination of the tax character of the distributions paid in 2021 will be reported to shareholders in early 2022 on Form 1099-DIV.
